



At Dogland Dog Park your dog will enjoy off-leash play in open spaces with pre-screened playmates, fresh air and the beauty of the countryside. There are several separate fenced areas so you can choose which area your dog will enjoy the most. One of these is the play yard for little dogs! Any dog under 14" needs to stay in this area. Another area is sectioned off for the agility course, and there is a separate area for ball launching and disc throwing.

It's quick and easy to join Dogland Dog Park:

- To ensure social compatibility and a safe environment for all dogs and humans at the Dog Park you are required to schedule your dog for an appointment for a temperament test. This 10-15 minute test ensures that your dog will enjoy the company of other playmates and then you are on your way to a fun-filled time at Dogland Dog Park. Once your dog has passed the temperament test and we have current vaccination records and proof of spay/neuter on file you are on your way to a fun filled time at Dogland Dog Park. Vaccinations include Rabies, DHPP (D = Distemper, H = Infectious Canine Hepatitis, P = Parainfluenza, P=Parvovirus) and Bordetella (Kennel Cough).
- A one-time \$20 non-refundable fee is charged for testing.

Rules & Regulations

These rules are necessary for the well-being of all users of Dogland Dog Park. Please be respectful of all guests and have FUN!!

Park Hours: 8 am – Sunset

1. All dogs must pass a temperament test prior to visiting Dogland Dog Park.
2. All dogs must be healthy, have current rabies, Bordetella and DHPP vaccinations on file at Dogland Dog Park.
3. Remove your dog's leash after passing through the entry gate. Mixing leashed and unleashed dogs commonly causes problems. Leashed dogs often feel threatened by the free dogs and will display provocative body language and defensive behavior.
4. Dog owners must have a leash available on their person at all times.
5. Dog owners must maintain control over and remain with their dog(s) at all times.
6. Aggressive dogs are strictly forbidden. Any dog showing aggression towards humans or other dogs must be immediately leashed and removed. Aggressive behavior (growling, posturing, nipping, etc.) must be immediately stopped by the owner of the dog.
7. Dog fights. To avoid a dog fight, you must be able to control and command your dog while in the park. You must keep watch of your dog(s) and be within command distance of your dog(s) the entire time that you remain in the park.
8. For the safety and enjoyment of all, there will be no rough play tolerated in the park.
9. Puppies under 4 months of age are prohibited.
10. Only neutered dogs will be allowed to enter Dogland Dog Park. Female dogs in heat are prohibited.
11. Owners must remove dog waste. Waste stations are provided for your convenience.
12. Pond access is for dog enjoyment only. Adults who cannot swim and children under 16 are not allowed within 4 feet of pond. No children are ever allowed to go near the pond. Adults are not allowed in the water except for an emergency rescue of pet or person.

13. Many dogs are not socialized with children. Keep children close and allow no running or screaming. Do not allow your children to approach a dog without permission from the dog's handler.
14. Children under 4 feet tall are not allowed in the park. One adult to supervise several children and the family dog(s) is not enough. Make sure you can take care of everyone you bring with you.
15. Children should not make direct eye contact with dogs as it may be misinterpreted as confrontational and a challenge to the dog. A child is at just the right height for this, and therefore, at risk.
16. Children under the age of 18 must always be within direct supervision while on park property and are never to be further than 10 feet from an adult. Children must follow all rules and not be allowed to destroy any property, including pulling on, standing on, leaning on any fence, park equipment, dog training equipment or any other assets of Dogland Dog Park. Children are not permitted to run, scream, chase or play sports in Dogland Dog Park.
17. A dog park is not the place to bring a child to get over their fear of dogs.
18. Dogs must be leashed at all times outside of the fenced Dogland Dog Park area.
19. For safety reasons, pronged (pinch), spiked, studded and choke chain collars are prohibited and must be removed before entering Dogland Dog Park. Remove harness and gentle leaders.
20. Squeak toys, tug of war toys, dog bones, chew treats, etc. are not allowed in the park while other dogs are in the park. If you, your guest(s) and your dog(s) are the only ones in the park toys are allowed.
21. Glass containers are prohibited.
22. Excessive barking dog(s) must be controlled or removed from Dogland Dog Park.
23. Owners must stop their dogs from digging and immediately fill any holes.
24. Limit of two dogs per adult owner in the park at a time.
25. Dogland Dog Park reserves the right to revoke any membership at any time if it is determined that your dog's social skills are not sufficient for safe interaction with other dogs or people.
26. Dog owners must remain inside the park within view and voice control of their dogs at all times with leash in hand. Know your dog and always keep your eye on them when other dogs are around. Not all dogs are good candidates for an off leash park. If your dog has not had regular and direct interaction with other dogs, it may lack the necessary social skills to make your visit safe and enjoyable. Leash up and leave if you are having difficulty controlling your dog around other dogs and humans. Private training is available at Moon Valley Pet Lodge to develop your dog's social skills.
27. During inclement weather, special events or routine maintenance Dogland Dog Park may be closed. Please call (815) 845-2379 before visiting or become our friend on [Facebook](#).
28. Please remove all objects that you brought into the park.
29. Contact Dogland Dog Park management to handle any dog grievances.
30. Dog owners must close all gates immediately after entering or exiting the park.
31. Guests and dog owners assume all risk when using Dogland Dog Park.

Failure to comply with these rules can result in removal, suspension and or termination from Dogland Dog Park.

Photo Release and General Release of Liability

I understand and expressly agree that this release, waiver and agreement is intended to be as broad and inclusive as permitted by the laws of the State of Illinois and that I have carefully read this release and know the content of the release, and sign this release as an act of my own free will, and that the terms of this release are contractual in nature and are not just a recital.

I am not relying on MVPLDDP or its staff, volunteers, management or owners, to prevent such occurrences. I hereby waive any and all claims or action that I, or my guardians, representatives, or assigns may have against MVPLDDP, and agree to release MVPLDDP from any and all liability for personal injury to myself, my dog, children in my charge, or harm to property caused directly or indirectly by acts that might occur while at MVPLDDP premises. I further agree to indemnify, defend and hold MVPLDDP harmless for damage, loss liability or expenses, including legal costs and attorneys' fees which result from any damage caused by myself, children in my charge, or dog(s) that I own or handle.
